How did you collaborate and coordinate your investigation efforts with the other professionals on your case? As a CASA volunteer, I first conduct an independent investigation and then write a report. The CASA Staff provided me with the initial information needed to start. Then I gather information from school teachers and staff, therapists, police departments, parole officers, and others. It is important to listen and learn as each professional is doing their responsibility within their field of expertise. My goal is to be respectful and professional to each person involved in the investigation.

Which three qualities or skills should a prospective CASA volunteer possess?

As a CASA volunteer, the three qualities I think are important are being able to put aside personal feelings or biases, being trustworthy, and being a willing learner. These qualities allow me to not be influenced or draw conclusions based on feelings but to be able to look at all the components of each child's situation. I can talk with various people and be trustworthy with what I hear or am told. As a CASA volunteer, I enjoy learning whether it is at the annual CASA conference, a book that is recommended by another CASA volunteer, or a "Coffee with CASA" event. All these qualities help me to best serve a CASA child.

If you were speaking with people considering becoming a CASA Volunteer, what would you tell them? As a Lucas County CASA volunteer, you will receive the support and training you need to help the child. I can honestly say, in my opinion, Lucas County CASA is the best in Ohio. It will be tough at times but you will often make a difference for a child that can last a lifetime.
