It gives me hope for their futures and feels like a true calling to give back in the same way others have supported me.



I approach providers with openness and respect, knowing they are often overwhelmed and doing their best. I introduce myself, explain my role, and request needed information, usually by email, followed by a call if needed. Sharing information back and forth makes the process easier for everyone, while respecting what must stay confidential. I always provide my contact information so communication stays clear and accessible.

#### **Most Impactful Experience**

I've had the privilege of watching a child grow from anger and struggle into a confident, thriving teen. By building trust and giving him space to use his own voice, he has become more engaged in his case, found healthy outlets, and is now excelling in school and activities. Witnessing his growth has been one of the most rewarding parts of being a CASA.
